

iPad Challenge Promotion - Terms & Conditions

1. Information on how to enter & prizes form part of these terms & conditions. Any entry not complying with these terms and conditions is invalid.
2. Entry is open to residents of Australia who are aged 13 years or older and who are not an employee of the Promoter or the Promoter's related companies, and any agencies associated with this promotion and their immediate families (including spouse, defacto spouse, parent, child or sibling (whether full, half, step or by adoption)). Entrants under the age of 18 must have the permission of their parent or guardian to enter the promotion. For any winner under 18 years of age, the prize will be awarded to their parent or guardian on their behalf.
3. The competition commences at 11.59pm AEDT on 09/01/2022 and closes at 11.59pm AEDT on 06/03/2022 ('Promotional Period').
4. To enter a participant must do one of the following within the Promotional Period:

5. There is no limit to the number of entries a participant can submit within the Promotional Period. All eligible entries will be automatically entered into the judging ('Eligible Entrant').
6. No responsibility is accepted for lost entries. Any entry not complying with these terms and conditions is invalid.
7. The Promoter reserves the right to verify the validity of entries and reserves the right to disqualify any entrant for tampering with the entry process, or for submitting an entry that is not in accordance with these terms and conditions.

- a) Entries must be made with iPad and Apple Pencil. To validate this, we may ask for proof.
 - b) Entries must incorporate text in some form. They cannot include only illustrations or visuals.
 - c) Entries can be produced in any suitable app available on the Apple App Store.
9. The judging will be conducted by a panel including members of the Student Edge team and Samuel Suresh. The judging will take place at 2.00pm (AEDT) at Student Edge, 2/454 Roberts Road, Subiaco, WA 6008 on 08/03/2022 for the Challenge Winners and every Monday on the following week commencing 10/01/2022 for the Weekly Winners.
